NOTIFICATION

The following draft amendment which is proposed to be made to the Dadra & Nagar Haveli Motor Vehicle Rules, 1991 is hereby published, as required by Sub Section (1) of Section 212 of the Motor Vehicle Act, 1988 (Central Act No. 59 of 1988), as amended by Act 54 of 1994, for information of the persons likely to be affected thereby and notice is hereby given that the said draft amendment will be taken into consideration by the Government on the expiry of fifteen days from the date of publication of this Notification in the Official Gazettee.

All objections and suggestions to the draft amendment may be forwarded to the Deputy Director (Transport), Transport Bhawan, Village- Athal, Silvassa, DNH before the expiry of fifteen days from the date of publication of the Notification in the Official Gazettee.

DRAFT AMENDMENT

A Notification further to amend the Dadra & Nagar Haveli Motor Vehicle Rules, 1991.

In exercise of the powers conferred by Section 65 and 211 of Motor Vehicle Act, 1988 (Central Act 59 of 1988) and as amended by Act No. 54 of 1994, and in supersession of Notification No. ADTr/DNH/Reg. Num/2008/6949 Dated 11TH May 2011, the

Administrator of Dadra & Nagar Haveli is pleased to amend the Dadra & Nagar Haveli Motor Vehicle Rules, 1991 as follows:

1). Short title and commencement:

- (1) These Rules may be called the Dadra & Nagar Haveli Motor Vehicle (Amendment) Rules, 2017.
- (2) They shall come into force from the date of publication in the Official Gazettee.

2). Amendment of Rule 58A:

In Dadra & Nagar Haveli Motor Vehicle Rules, 1991, existing Rule 58A shall be substituted as below:

1. For assignment of Jumping Registration Numbers for a vehicle of the choice of the applicant, the following fees shall be levied as per the terms and conditions mentioned below:

4	Transport / Commercial Vehicle	Q	₹ 10,000/-

1. There will be one separate series for allotment of registration numbers for Motor Cycle / Two Wheelers. The registration numbers will be from 0001 to 9999.
2. There will be another one separate series for allotment of registration numbers for Light Motor Vehicles (LMV) and Transport Vehicles. The registration numbers will be from 0001 to 9000 and 9999 for Light Motor Vehicle and registration numbers from 9001 to 9998 for the Transport Vehicle.
3. For Motor Cycle / Two Wheeler numbers from the pending series i.e. N from 0001 to 3000 will be allotted first and then from next series i.e. P: from 0001 to 3000.
4. For Light Motor Vehicle (NT) numbers from the following running series will be allotted first: from Q – 0001 to 9000.
5. The routine registration numbers for vehicles belonging to the Government or Semi-Government or Government Undertaking irrespective of class i.e. Motor Cycle / Light Motor Vehicle (LMV) / Transport Vehicles shall be allotted through current / running / prevailing series.
6. The fee for allotment of a registration number at the choice of the applicant is specified in Schedule – I to IV appended to these rules.
7. The available numbers specified under Schedule – I - IV shall be allotted on 1ST working day of each month. If there will be a holiday, allotment will be done on next

working day. If the applicant or his representative remains absent during the allocation of choice number, the fee paid will be forfeited without any intimation, if there are two or more applicants for the same number.

8. The owner of vehicle desiring to obtain a number of his choice under this rule shall submit an application in FORM – CNA (Choice Number Application) with a copy of Form – 21 (Sale Certificate) along with prescribed fees specified in Scheduled – I - IV in form of Demand Draft in favour of “Deputy Director (Transport) payable at Silvassa” to the Registering Authority in sealed cover / envelop with “Choice Number – Two Wheeler or LMV (NT) or Transport Vehicle” written over it with name, address and mobile number.
9. Whenever more than one person applies for the same registration number specified in Scheduled – I - IV; the number shall be allotted by way of auction.
10. Allotment of registration numbers by way of Auction shall be carried out by the Registering Authority in accordance with the procedure laid down by the Secretary (Transport) as under, namely:
 - i.) The bidder shall submit his bid in form of Demand Draft in favour of “Deputy Director (Transport) payable at Silvassa” in sealed envelope / cover with “AUCTION – Two Wheeler or LMV (NT) or Transport” written over it with name, address, mobile number and particular registration number bidder wants to participate / apply.
 - ii.) A qualified bid which is the highest in amount shall be selected as winner for allotment of a particular auction number.
11. Selected applicant / candidate for the Choice Number / Auction Number have to apply for registration with three days from the allotment of registration number. At the time registration, if documents for registration are not as per prescribed under the Central Motor Vehicle Rule, 1989, allotted Choice / Auction Number will be rejected automatically.
12. Whenever only single application is received for any registration number specified in Schedules – I to IV, the registering authority shall reserve a registration mark to the owner of a Motor Vehicle of his choice from amongst the registration marks specified in Schedules – I to IV appended to these rules and the fee for allotment of such numbers shall as specified in the said Schedules. These numbers shall be allotted only after payment of the fee specified.

Provided that, at the end of completion of the current / running / prevailing series, in the event of any such registration numbers remaining un-allotted specified in Schedules – II to IV would be allotted in routine manner.
13. The routine registration number shall be allotted strictly on the basis of first come first serve to be determined on the basis of date and time.

14. The registration numbers under these rules shall be allotted only from the current / running / prevailing series in the jurisdiction of the concerned Registering Authority, subject to the availability. No request for allotment of registration number from a series not yet opened shall be entertained.
15. New series will be opened automatically after exhausting the numbers in the current / running / prevailing series.
16. An Application for obtaining either a Choice Number or Jumping Number or Routine Number shall be made to the Registering Authority within thirty days from the date of sale certificate / sale invoice or the date of insurance, whichever is earlier;

Provided that, an application for obtaining a choice number shall be made to the Registering Authority within thirty days from the date of issuance of certificate in Form No. "22A" by body builder of the vehicle where a body is fabricated separately.

17. An application made either for Choice Number or Jumping Number or Routine Number after the prescribed time limit as specified in Clause – 16, the applicant have to pay additional fees of ₹ 3,000/- for Light Motor Vehicle, ₹ 2,000/- for Two Wheeler and ₹ 1,000/- for Transport / Commercial Vehicle per month.
18. Registration Numbers so allotted under these Rules will be non-transferrable and shall not be changed subsequently. The fee paid for the purpose will be non-refundable.
19. The allotment registration number as mentioned in Clause No. 1 and 2 above, shall be only after completion of respective current / running series
20. The registering authority shall give wide publicity regarding opening of new series.
21. The decision of the Registering Authority as regards issue of Registration Numbers shall be final.
22. These rules shall supersede all the orders or instructions issued earlier in this regard.
