NOTIFICATION

1. Whereas under Section 29 of the Town and Country Planning Act as extended to the Union Territory of Dadra and Nagar Haveli, the Dadra and Nagar Haveli Planning and Development Authority has prepared an Outline Development Plan for the horizon 2031.
2. Whereas, the Dadra and Nagar Haveli Planning and Development Authority in its meeting held on 18th March 2010 had deliberated on the Outline Development Plan in detail and suggested certain modifications which was undertaken and the proposal was submitted before the Authority meeting again which was held on 14th July 2010.
3. Whereas, in the meeting held on 14th July 2010, the Authority recommended the Outline Development Plan for the approval of the Town and Country Planning Board.
4. Whereas, the Town and Country Planning Board in its meeting held on 30th April 2011 recommended the Outline Development Plan 2031 for approval of the Hon'ble Administrator under Section 34(2) of the Town and Country Planning Act;
5. Whereas, the Hon'ble Administrator approved the Outline Development Plan under Section 34(2) of the Town and Country Planning Act and further directed to notify the Draft Outline Development Plan (ODP) 2031 for inviting comments and suggestion from General Public as required under Section 35 of the Town and Country Planning Act.

Now, I, Member Secretary, Dadra and Nagar Haveli Planning and Development Authority, is hereby pleased to notify the Draft Outline Development Plan 2031 on behalf of the Planning and Development Authority under Section 35(1) as approved by the Administrator under Section 34(2) of the Town and Country Planning Act for inviting Comments/ Suggestions in writing from the public within a period of two months i.e. 60days from the date on which this Notification is published in the Official Gazette.

The copy of the Draft Outline Development Plan 2031 is kept in the office of the Member Secretary, DNHPDA and Office of the Chief Town Planner at Secretariat, Silvassa. A copy of the Plan and Report is also available in the office of the Mamlatdar at Silvassa and Khanvel for inspection by the general public on all working days during office hours. The ODP report along with the Draft DC Rules is also available on sale in the office of Planning and Development Authority at a price of Rs 2000/- (Rupees Two Thousand only) to be paid in cash only.

Any comments / suggestions received after the expiry of two months i.e. 60 days shall not be considered or accepted.
