The Chief Officer, Silvassa Municipal Council, Silvassa, on behalf of the Silvassa Municipal Council, Silvassa invite sealed tenders (i) from the Govt. approved and eligible contractors, for various civil works as mentioned at Sr. No. 01 to 19 to be undertaken by the Silvassa Municipal Council and 2) from eligible persons/resident of Silvassa Municipal Area not less than 15 years for renting of 01 to 28 nos of shops as mentioned at Sr. No. 20 constructed on land bearing plot no. 135 of Village Silvassa. The tender should be reached to the undersigned on or before dated: **13/8/2010** at 15.00 hrs by RPAD or to be deposited in the tender box kept separately for works and shops in the office of the undersigned in separate envelop for each item/each shop. The tender form for each item with detailed specification/each shop with terms and conditions can be obtained from the office of the undersigned on payment of **tender fees of Rs. 500/-**, for works at Sr. 1 to 19 and **Rs. 1000/-** for each shop in cash (Non refundable).

The tender copy for Item No. 18 & 19 shall be issued to those contractors/agencies who are Government approved electrical license contractor and possessing valid registration issued by State Govt./PWD/CPWD or by Urban local Bodies for electrical works.

The blank tender form for each shop separately for renting shall be issued to those persons who are residents of Silvassa Municipal Area for not less than 15 (fifteen) years and on production of proper and legal evidences in respect to his/her residential proof and experience for running of business/trade for which he/she intending to apply, alongwith the application for allotment of shop on rental basis.

The Earnest money in the form of fixed deposit receipt valid for a period of six months or more from any **Schedule bank** drawn in favour of the Chief Officer, Silvassa Municipal Council, Dadra and Nagar Haveli, Silvassa should be furnished along with the tender documents. The Earnest money deposit should not be forwarded by case / Cheque and the tender without earnest money deposit in above manner will be summarily rejected.

It should be noted by the contractor that a sum of the gross amount of the bill on account of Civil Work shall be deducted for each running bill till the sum along with the sum already deposited as EMD will amounts to SD @ 10 % of the tender value of the work.

In addition to above, the contractor shall be required to deposit on account of civil work an amount equal to 5% of the tender value of the Contract as Performance Security within the period prescribed for commencement of work in the letter of award issued to him.

It should be noted by the contractor that a sum of 1% on the tendered/actual amount will be deducted towards labour cess from the bills of civil work. It is a responsibilities of the concerned agency/contractor for payment sale tax, VAT etc as applicable time to time and if required shall be deducted from the bills payable to the agency (present rate of VAT is 4% as a TDS and shall be recovered from the bill to be paid to the agency).

The application and fees for issuance of tender documents from eligible contractor will be accepted upto **05/08/2010** up to 15.00 hours and blank tender documents will be issued to eligible contractor/persons during this period i.e. up to **09/08/2010** up to 16.00 hrs. on production of the Valid Registration, Income Tax Clearance Certificate and certificate from the Government/Semi Government, ULB/Corporation for satisfactory completion of work executed in past, list of work(s) on hand with the tender amount should also be enclosed with the application for tender in respect to Civil Works and residential poof & experience certificate in case of allotment of shop on rental basis. The tender fees are non-refundable.

For the work an agency considered as special categories-III and above for road/ Building works by Government of Gujarat or its equivalent declared by any states/central government or U.T. administration or by ULBs will only be considered eligible for issuance of blank tender document. The blank tender will be issued to those contractors/firms who are specialized in particular works.

Before acceptance of application, contractor will have to produce the following documents in addition to the other documents for qualifying.

1. Experience certificate duly certified from the competent authority, for the same
2. Nature of works competed in past satisfactorily.
3. List of works on hand as on date and schedule program for completion thereof.
4. Detailed list of plant and machineries owned by the agency.

Right to acceptance of the tender application & issue the blank tender documents are reserved by the undersigned. Agencies registered with the Sales Taxes Department, D&NH or having CST/VAT Registration of any state, in case of issue of tender document for civil works, will only qualify for availing the blank tender documents .

Agency will **quote rate in figure and words** for each item and should work out the requisite total. The Rates, amount and total should invariably be given in figure and words without fail, the envelop should be sealed with wax and seal of organization/institution/agency should be affixed properly, failing that, tender will not be considered. Blank tender will not be supplied by post. The Tender Notice is published in www.dnh.nic.in web site of UT of Dadra & Nagar Haveli.
